SUMMARY: Mr. Kamayana is a national of Indonesia and retired in May 2014 from the Asian Development Bank after 18 years of service. In his final assignment in ADB, he spearheaded ADB's re-engagement with the Government of Myanmar, as its first representative from July 2012 following the country's re-engagement with the international community in 2011, and established ADB's first resident mission in Myanmar. He coordinated ADB's effort to assist the Government of Myanmar to clear its loan arrears with ADB, working closely with senior officials of the Governments of Myanmar and Japan and the World Bank, as well as planning of ADB's new initial investments in Myanmar amounting to \$1 billion over three years. Prior to Myanmar, he served as ADB's Country Director in Cambodia as well as Deputy Country Director in both Viet Nam and Bangladesh. In Cambodia, he oversaw an assistance program of over \$770 million in projects under implementation with another \$150 million per annum in new loan commitments and technical assistance, spanning infrastructure (transportation and electric power), agriculture and irrigation, urban development, secondary education and vocational training, financial sector development, private sector development, rural development, environmental management and climate change. As ADB's representative in Myanmar and Cambodia, he engaged in policy dialogue with ministers and senior Government officials on how ADB can best address each country's development priorities and coordinated closely with ambassadors and heads of aid organizations to promote collaboration. He strongly advocated a consultative approach in program and project formulation, including with representatives of the business community, non-governmental organizations, civil society, academia and project-affected grassroots communities. He actively sought opportunities to apply innovative mechanisms to address climate change and promote sustainable development.

In his assignments, Mr. Kamayana has actively promoted collaboration with other multilateral and bilateral development partners/donors on the planning, financing and implementation monitoring of projects, as well as promoting private sector investment which have resulted in substantial additional funding to supplement ADB's investments. Examples of projects jointly financed by multiple sources include: in Bangladesh power sector development (with Japan, Canada, UK, Germany and the Netherlands), road network improvement (with Japan, OPEC Fund, UK and the European Union), irrigation systems development (with the Netherlands), primary education (with Germany, Japan, EU, the Netherlands, UK, the World Bank-WB), urban primary health care (with Sweden, UNFPA, WB), road improvement (with Germany, UK); in Viet Nam transport infrastructure (with WB, Japan, UK and France), power generation and transmission (with WB, Japan, UNDP, Australia, Sweden, Norway), private sector development (with EU, Germany, Japan, UNIDO, IMF, WB), public-private partnership for infrastructure development (with WB, Japan, UK), local government capacity building (with WB, Japan, UK, EU, Australia, Sweden), rural infrastructure (with WB, EU, UK, Denmark, Finland); and in Cambodia road maintenance (with WB, Australia), rural development (IFAD, Finland), railway rehabilitation and privatization (Australia), and irrigation (France, OPEC Fund). Jointly financed projects are typically implemented by borrowing Governments under ADB supervision and the investment funds are then disbursed in progress payments proportionally between ADB and the other funding sources, for eligible expenses as set out in the financing agreements. Mr. Kamayana has also availed of funds contributed by other donors for specific technical assistance (TA) activities (e.g. climate change, capacity building, etc.) administered by ADB, which are held in trust until disbursed through approved TA projects.

Since retirement, Mr. Kamayana has undertaken brief consultancy assignments as an adviser to a local real estate developer based in Mandalay, Myanmar in mid- to late-2014, and in 2016 as team leader/regional cooperation specialist for an ADB-financed technical assistance (TA) project to prepare a complex, multi-sector multi-tranche financing facility (MFF) project in Guangxi Zhuang Autonomous

Region of the People's Republic of China for which ADB approved a loan of \$450 million out of total project costs of \$1.2 billion over three tranches. In 2018, he was engaged in a multi-disciplinary team as development economist under an ADB TA, to identify and prioritize border towns in the Greater Mekong Subregion (GMS) with potential for construction of cross-border economic zones to create jobs and increase economic cooperation and trade amongst the GMS countries, for consideration of ADB support for infrastructure improvements and socio-economic development. Since March 2019, he has been engaged intermittently as team leader to coordinate a large team of consultants and ADB staff in the preparation of a project loan proposal for establishing a green financing mechanism to catalyze private sector capital sustainably for meeting Indonesia's infrastructure development needs and its SDG and Paris Agreement on Climate Change (COP21) commitments.

His prior assignments also included formulating and monitoring implementation of ADB's country strategies and assistance programs in Kazakhstan and Turkmenistan. He also has undertaken project formulation and administration tasks for loan-financed and technical assistance projects, encompassing a range of development sectors including rural infrastructure, primary education, and rural poverty alleviation. He is also a strong believer of the benefits of regional cooperation for his countries of assignment, and has been involved in several of ADB's regional cooperation support initiatives, such as for the Greater Mekong Subregion (GMS), Association of Southeast Asian Nations (ASEAN), Brunei Darussalam-Indonesia-Malaysia-Philippines East Asia Growth Area (BIMP-EAGA), Indonesia-Malaysia-Thailand Growth Triangle (IMT-GT), South Asia Subregional Economic Cooperation (SASEC), and Central Asia Regional Economic Cooperation (CAREC) programs.

Before joining ADB, he served 9 years in the United Nations Development Programme in both the Bangladesh and Indonesia field offices, and in the New York headquarters with responsibilities ranging from planning and implementing technical assistance in regional cooperation, transport and energy infrastructure, urban development and governance sectors, to program monitoring and heading the finance and administration section of one of UNDP's largest field offices. After 5 years professional experience as an architect in the United States, earning a license to practice architecture in the State of California and an MBA, Mr. Kamayana returned to Indonesia in 1982 where he joined a team planning a new city on Batam Island, adjacent to Singapore, as well as advised on improving management practices in one of the well-established national architecture and engineering consulting firms.

Mr. Kamayana now resides in Jakarta and is married with three children.
